These cookies help us understand how visitors interact with our website by collecting information anonymously. This allows us to improve website performance and user experience.

Examples include pages visited, time spent on the site, and error messages.

**Lawful basis:** Consent

## Functional Cookies

Functional cookies enable enhanced functionality and personalisation, such as remembering your preferences or settings.

**Lawful basis:** Consent

## Marketing Cookies

Marketing cookies are used to track visitors across websites. They are intended to display adverts that are relevant and engaging for individual users.

Compliance Pigeon Limited does not use third-party marketing cookies unless you have provided explicit consent.
